# **Teaching**

# **Teaching Self-Appraisal**

Calendar year 2017 brought with it many items of distinction in the teaching category.

On campus distinctions include nomination and subsequent election to join the TEACHING ACADEMY at Texas Tech and selection to participate in the INSTITUTE FOR INCLUSIVE EXCELLENCE offered by Texas Tech's Teaching, Learning, and Professional Development Center.

Off campus opportunities included an invitation to join the faculty of the BOSTON UNVIVERSITY TANGLEWOOD INSTITUTE, the high-school program of the Tanglewood Music Center. This teaching involved daily masterclasses and coachings for some of our nations most talented high-school performers over the month-long institute.

Student success remains high, with a remarkable full-studio achievement of ALL 19 MEMBERS being selected to participate in the invite-only rounds of the NATIONAL TRUMPET COMPETITION. Included in these were three separately coached trumpet ensembles, and three student soloists. This was the largest number of participants from a single institution in the history of the competition, with a special recognition of this feat announced at the awards ceremony of the competition.

Students were also awarded competitive scholarships in 2017, with two TMEA SCHOLARSHIPS in the amount of \$2500 awarded to studio members.

A graduate student was selected to participate in the prominent CHOSEN VALE summer festival, and an alum accepted a head band director position out of state in North Carolina.

STUDENT EVALUATIONS remain among the highest in our department with qualitative comments unanimously positive. Enrollment is right on track, with a healthy studio of 19, including three graduate students.

NEW INITIATIVES involving technology are constantly being added to the curriculum. All lessons have the ability to be recorded as both audio and video, with instant availability via youtube for students. This has even opened up the studio to outside collaboration with a community of other trumpet professors via social media outlets. Presentations about this will be given at two important conferences in 2018.

2017 marked continued service on recital committees at graduate and undergraduate levels,

including service as chair for two DMA students who are in their final year.

# **Research and Creative Scholarship**

#### **Research and Creative Self-Appraisal**

2017 showed an expansion in creative activity both in and type of activity.

Performances with orchestras continued with section duty in the ALBANY SYMPHONY in New York. Notable this year were performances of Stravinsky's "The Rite of Spring" and John Corigliano's "Symphony No. 1." This performance was video recorded for a DVD documentary about this work. A principal trumpet with the STEAMBOAT SPRINGS SYMPHONY in Colorado was a notable endeavor, as were local principal performances within orchestras housed at Lakeridge United Methodist Church, First United Methodist Church, and the Lubbock Chorale.

Chamber opportunities included joining the BALA Brass, which was selected in a national search to be the brass quintet in residence at the BOSTON UNIVERSITY TANGLEWOOD INSTITUTE. Duties for this included a full recital performance, and I was able to find opportunities to perform and collaborate with others on additional performances as well. I have rated the prominent recital as a 5 because of the international reputation of the venue and the publicity all Tanglewood events receive. The Boston University Tanglewood Institute is considered to be the high school program of the acclaimed Tanglewood Music Center.

A SOLO PERFORMANCE with the TTU Symphonic Band kicked off a full-length recording project. This has been partially funded by the DEANS ADVANCING CREATIVE SCHOLARSHIP GRANT, which was awarded this year. Two trumpet and piano works, including my own transcription of four songs by Charles Ives have also been recorded for release on this album. Additional grants have been applied for, including the PROVOSTS SCHOLARSHIP CATALYST AWARD. That award is still under consideration. This project will continue into 2018.

Solo recitals continued both on campus and off, with a notable recital performance at the UNIVERSITY OF UTAH. This is ranked high because of the selectivity of the invitation. A masterclass was also given as part of this trip.

Adjudications and clinics occurred at various venues, including an invitation to adjudicate at the NATIONAL TRUMPET COMPETITION. This is ranked high because of the selectivity of the process. Most judges are esteemed professors and performers from the United States. Adjudication was also provided for the KLEIN ISD Solo and Ensemble Contest. This is comparable to a UIL contest, as the district hosts their own events in lieu of UIL participation. In addition a sectional presentation for the TMEA ALL-STATE CONCERT BAND was presented at this years' convention.

This year also marked the first time a full-length arrangement of mine was performed in a national venue. One of the Texas Tech Trumpet Ensembles that performed at the NATIONAL TRUMPET COMPETITION performed my arrangement of excerpts from Shostakovich's Piano Concerto No. 1. This fall an arrangement of Holst's Jupiter was completed and entered in the competition for the 2018 year.

# Plans for the Next Academic Year

2018 marks the start of an application for tenure and promotion, and I look forward to a successful completion of this process.

#### Teaching

2018 will be an exciting year of teaching. Once again, the ENTIRE STUDIO has been invited to compete at the NATIONAL TRUMPET COMPETITION, with two ensembles and four soloists. I look forward to preparing students to perform to the best of their ability.

The trumpet ensembles have also been invited to perform at the INTERNATIONAL TRUMPET GUILD CONVENTION in San Antonio, TX this summer. This is after a review of submitted recordings.

In addition to this the 2018 calendar year will see students from my studio performing approximately 12 degree recitals including four graduate degree recitals. It will be a busy time in the trumpet studio.

#### Scholarship and its Equivalents

2018 promises to be an exciting year. An ongoing CD recording project will be completed with a concerto recording and solo performance with the University Symphony Orchestra. The CD will be released over the summer.

Already many invitations have been extended to perform in symphony orchestras. This includes the remainder of the ALBANY SYMPHONY subscription series in New York. This includes a performance in April at the KENNEDY CENTER in Washington, DC.

In addition to this, I have been asked to perform a week with the ALABAMA SYMPHONY, one of our nations few full-time orchestras.

A solo performance is scheduled for the summer at the INTERNATIONAL TRUMPET GUILD CONFERENCE, as well as an ensemble performance and a clinic presentation on the Teaching and Recruiting Power of Social Media. A modified version of this presentation will also be presented at the TEXAS MUSIC EDUCATORS ASSOCIATION CLINIC/CONVENTION in 2018.

I am also looking forward to seeking publication outlets for my own transcription of a set of Ives songs for Trumpet and Piano, and my growing library of trumpet ensemble arrangements.

I have reviewed the materials submitted by Dr. Andrew Steson. In addition, I reviewed the numerical ratings in the various research categories and found them to be appropriate and made modifications where necessary. Coupled with my direct interaction during the calendar year 2017, these materials provide the basis for the following review. Dr. Stetson is non-tenured, holding the rank of Assistant Professor, with teaching responsibilities in trumpet.

#### **Teaching 50%**

Dr. Stetson's studio trumpet teaching is exemplar by every measure. He has one of the most active and accomplished studios in the School of Music. His students place high value on his instruction and mentorship as documented by both written comments and numeric data provided by student evaluations of course and instructor. His students have not only been recognized in national venues such as the National Trumpet Competition, but their playing as integral members of all ensembles in the School of Music has been most noticeably first rate and a vast improvement in both quality and consistency when compared to performance prior to Dr. Stetson's arrival.

Notable appointments and performances serve to reinforce the rising value of his pedagogical skills. The appointment to the high school division within the Tanglewood Institute is one such example of this rising recognition. On campus, admission into the Teaching Academy and being named an Integrated Scholar are both impressive recognitions in this area.

The uniformity of improvement and adherence to standards of excellence in performance by his entire studio is a commendable accomplishment that should be the standard for studios of his peers. He is quickly achieving a status of a rising trumpet artist and pedagogue, evident by the increased interest students show in joining his studio.
